**MINUTES OF THE REGULAR MEETING OF BOARD OF TRUSTEES  
FOR RECLAMATION DISTRICT 1608  
HELD WEDNESDAY, FEBRUARY 7, 2018**

The Regular Meeting of the Board of Trustees of Reclamation District 1608 was held Wednesday, February 7, 2018 at the law office of Neumiller & Beardslee, 509 W. Weber Avenue, 5<sup>th</sup> Floor, Stockton, California, at the hour of 8:00 a.m.

**Item 1. Public Comment.** Under Government Code Section 54954.3, members of the public may address the Board on any issue in the District’s jurisdiction. The public may address any item on the agenda as it is taken up. Dominick Guilli distributed a letter identified as 2/7/2018 Written Public Comments. He requested that this letter, including attachments, be included with the minutes of the meeting and said it was because the information contained in the attachments have a significant effect on the environment and the public at large. The attachment to the letter includes a notification to interested parties of the approval of the Lower San Joaquin River Flood Risk Management Feasibility Study Report and said that interested parties have 30 days in which to comment on the Final Environmental Impact Statement as it is being filed with the Environmental Protection Agency and is being made available to interested parties for review and comment. He said “Please read it” and is asking that the District respond with written comments. He is asking that the District respond as, he said, the public can’t respond.

President Panzer also reported that former Trustee James Bluck passed away.

**Item 2. Minutes of the regular and special meetings of January 3 and 5, 2018.** The Trustees reviewed the minutes and

Upon motion duly made, seconded (B. Tholborn/D. MacDonnell) and unanimously carried by the Board of Trustees of Reclamation District 1608, the minutes of the Regular Meeting of January 3, 2018 were approved and upon motion duly made, seconded (/D. MacDonnell/B. Tholborn) and unanimously carried by the Board of Trustees of Reclamation District 1608, the minutes of the Special Meeting of January 5, 2018 were approved as read.

**Item 3. Financial Report. Review, discuss, and accept financial report.** Secretary Knight presented two sets of financial reports. The 1<sup>st</sup> report was for the fiscal period ending December 31, 2017 and the 2<sup>nd</sup> for the fiscal period ending January 31, 2018. She reported that for the 2<sup>nd</sup> report the District received \$118,074.46 in property taxes and \$152,172.15 in assessments. After review, the Trustees approved the financial report as presented.

**(a) Adopt Resolution 2018 Establishing Policy For Reimbursement Of Trustee Expenses.** Dan Schroeder presented this item and said the attorneys have been working on stipends and reimbursements for events. He noted that small Districts have not set aside any policies for these types of expenses and this resolution, along with Attachment A, the Reimbursement of Expenses Necessarily Incurred in the Performance of Trustees Duties, will help do so. He noted that this document creates the structure necessary to implement the policy and said at the next meeting there will be a report where one incurred their expenses to see how the policy works. Trustee Panzer said he thought the District already had some sort of a policy but Mr. Schroeder said no, it did not. After discussion,

It was moved, seconded (B. Tholborn/D. MacDonnell) and unanimously carried by the Trustees of Reclamation District 1608 that Resolution 2018-01, Resolution Establishing Policy for Reimbursement of Trustee Expenses be approved.

Later on in the meeting, attorney Schroeder spoke a little more about the above issue citing the Civil Grand Jury questionnaires that went out several years ago about the operations of special districts such as Reclamation District 1608. Although technically they can't force the District to do anything, it was felt that working together with a financial policy so everyone is being accountable for is a good thing and creating a system that is functional but reduces the potential for theft as much as possible is what he will be working on. He said he would be coming up with a title for the financial policy and will likely be presenting it at the April meeting.

**(b) Discussion and direction regarding Trustee Stipend.** Brett Tholborn had earlier brought this up for more discussion. He thinks that the current rate of stipend, \$100 per day of service (in practice, it is a meeting) is low and felt the amount was a bit archaic. Various ways to make changes were discussed by Attorney Schroeder. One way is to draft an Ordinance setting out the new fee schedule and then this Ordinance would be published in the newspaper for a number of weeks and then there would be a public hearing and there could be a referendum. The cost would be minimal to publish in the newspaper. He asked the Trustees if they were interested in proceeding with this idea and the response was yes. Trustee Tholborn thought \$300 for a day of service for the meeting would be a good amount. If there was an additional meeting, it was felt that this meeting (or day of service) would be kept at the \$100 a day. Mr. Schroeder said he would bring the draft ordinance back either the next District meeting or the following meeting.

**Item 4. Engineer’s Report. Request for directions and approvals.**

- (a) Consider new permits requests from homeowners. None.
- (b) Approval of Contract to Repair Levee Crown Subsidence Area in North West Levee Near Marina Property. Still pending.

From Engineer’s Report.

**Plan Review: Pending Permit Requests from homeowners; Dr. Antonio & Lillian Arrendondo, 6201 Embarcadero Drive, Stockton.** Chris Neudeck gave a verbal report and said he was working on a letter to the Arrendondo’s that would be going out shortly. He noted he had met with them recently and the meeting went well and he wanted to clarify things by writing a written report. He will present the letter at the next District meeting but thought the letter would be going out shortly. In the letter he will note the following:

- 1. They are approved to place lawn on the levee waterside slope of their lot.
- 2. They are approved to place artificial turf on the levee landside slope of their lot as noted by Mr. Neudeck.

Mr. Neudeck also noted that provided the District receives a revised set of plans with a new encroachment permit application the following will be agreed to:

1. They will be allowed to leave the fire ring on the levee waterside slope.
2. They will be allowed to transfer the fire ring and concrete pavers to the levee landside slope
3. They may be allowed to construct a deck in the area of the Fire Pit on the levee waterside slope provided it is in accordance with the District's Encroachment Standards; and
4. Their 2/7/18 submitted application and plans were not approved and need revision and resubmittal.

It was also agreed that with respect to the concrete surfacing of the levee crown, Mr. Neudeck has, at this time, agreed to delay enforcement on this encroachment until such time the District has completed its revisions to its Encroachment Standards. The District standards are currently being reviewed and one of the elements that they are considering is the type of allowable surfacing of the levee crown in the Southwest Quadrant. The District is currently considering allowance of concrete slab surfacing, providing the concrete slab surfacing is properly designed to handle the load of large earthmoving loaded trucks that use the roadway for levee access.

Mr. Neudeck also said that he has asked (and he too will do) that the Arrendondos please document what each says. There's also an issue with mail not going to the home address and some issues with mail being received by them at their Post Office Box.

**III. FEMA Mapping Status.** Mr. Neudeck referred trustees and staff to Exhibit A in the engineer's report where it notes that his firm has contacted the FEMA case manager and inquired as to the status of the LOMR. The FEMA case manager has received internal comments from their Quality Control Department and anticipates the LOMR approval by the end of this week.

When questioned about this issue and the LOMR, Mr. Neudeck was given direction to respond that the District is in a pending condition with FEMA as far as flood zones and that they can change at any time. However, FEMA so far has held off and the District submitted further information to them.

#### **V. Subventions Program.**

- A. Review progress of KSN Inc. annual Levee Inspection to evaluate landowner encroachments. Mr. Neudeck wants to put more effort into details of historical records on the lots. He noted that the records are not always clearly reported on what is approved and what is not. He is having an inspector review the files and clarify some of these matters. It should make for better tracking. Some of the files contain "grandfathered" approvals and they are trying to clarify. Questions such as, Is it a permitted or not permitted grandfathered? Is it something that the District should take active enforcement on? The work in the longrun will allow the engineers to get a better handle on the big picture. The Southwest levee is going to be more difficult. He said, engineers don't like bushes. They want to be more careful and as reported, they are reviewing the encroachment standards.



- B. Mr. Neudeck said they are reviewing the need for other minor All Weather Road Repairs in the southwest quadrant. An inspector is coming behind them when they are doing their inspection.

There is a condition that was discovered where there was work done by the City of Stockton and there appears to be a sink hole over an outfall location. Mr. Bryson noticed this and the soil below the crest is moist – might be latent moisture. The City is disturbed with the District calling them about this. If a pipe is leaking, they have to go down and look and it could be 6 – 12” deep. Mr. Neudeck said the District needs to coordinate with the City. He will let Mr. Schroeder know if this needs to be on the next District meeting agenda.

**IV. Sediment Removal Project:** At this time, Brett Tholborn left the meeting at 8:53 a.m. because of his conflict. Mr. Neudeck reviewed the items in Exhibit B. of the Engineer’s report. The exhibit is an update of the project with the tasks of, 1) Project Management & Design; 2) survey & Mapping; 3) Environmental Assessments & Documentation; 4) Dredging operations support & permitting; and 5) construction management. He discussed at what percentage the engineers are with each task and details of this status.

After discussion, Mr. Tholborn returned to the meeting at 9:10 a.m.

**Item 5. Levee Superintendent Report.** Request for directions and approvals. Joe Bryson gave his superintendent’s report and went through all the items.

**Item 6. Trustee Conflict of Interest.** Review trustee conflict of interest regarding sediment removal project. Dan Schroeder presented this item. He said the draft for reconsideration was done by Andy Pinasco for the FPPC. There are changed conditions with the dock and boat access. It was submitted February 1<sup>st</sup>. The time period that the FPPC can respond would be by March 5<sup>th</sup>. If they do nothing, then nothing changes. Dr. Panzer said letter looked brilliant and was very comprehensive. Mr. Schroeder said that Andy did an excellent report. Dominick Guilli made a public records request and he will get a copy of the letter.

**Item 7. Report by Trustees on meetings attended and upcoming meetings.** Request for direction.

**Item 8. Report and possible action on Progress of Tasks Assigned at Previous Board Meetings.** – No report, already discussed.

**Item 13. Report out of Closed Session.** A closed session was held and all trustees were present. There was no reportable action regarding items 12a and 12 b.

**Item 14. Employment Agreements.** Discussion and possible action regarding amendments to Levee Superintendent and District Secretary. The secretary's current salary is \$675 per month. Brett Tholborn said the cost of living increase for the state of California this last year was 2.6%. The Trustees recommended increasing the salary by 3% or \$20.00 to \$695 per month. Therefore,

It was moved, seconded (B. Tholborn/D. MacDonnell) and unanimously carried by the Trustees of Reclamation District 1608 that the salary for Secretary Knight be increased from \$675 to \$695 per month, effective March, 2018.

After discussion, the Trustees recommended a 3% increase for Mr. Bryson of \$1.00 an hour from \$36/hr. to \$37/hr. Therefore,

It was moved, seconded (B. Tholborn/D. MacDonnell) and unanimously carried by the Trustees of Reclamation District 1608 that the salary for Joe Bryson be increased from \$36 an hour to \$37 an hour, effective March, 2018.

**Item 15. Approval of Bills.** The bills, as presented, were approved.

**Item 16. Staff Reports.**



**Delta Levees Special Flood Control Projects Program – Five-Year Plan Solicitation**

Dear Ms. Knight:

**Introduction**

The Delta Levees Special Flood Control Projects Program (Program) is pleased to announce the release of the 2018 Five-Year Plan Solicitation (Solicitation). This Solicitation provides up to \$3,500,000 in local assistance funding from Propositions 1E and 84 for the development or update of Five-Year Plans to support levee work in the Delta that integrates levee and habitat improvement while protecting discrete and identifiable public benefits. **Note that continued eligibility for any Program funds will require that local agencies have an acceptable and updated Five-Year Plan on file with the Program.**

**Background**

The Program was established in 1988 by Senate Bill 34, and continues to operate under subsequent legislation that extends and provides funding for the Program. Originally authorized to address flooding on the Eight Western Islands, Thornton, New Hope, and Walnut Grove, the Program was expanded in 1996 to the entire Delta and to portions of Suisun Marsh. The passage of Proposition 1E and Proposition 84 in November 2006 significantly increased the amount of money available for levee projects in the Delta. The Department has invested over \$350 million dollars in flood control and habitat projects that are carried out by participating local levee maintaining agencies in the Delta. In 2009, the Program initiated cost share agreements to assist local efforts to produce Five-Year Plans for 60 Delta islands/tracts to support levee work. These plans were completed and are used to guide Program expenditures in the Delta.

**Five-Year Plan Cost Share Solicitation**

This Solicitation seeks eligible plans that include but are not limited to levee improvement, habitat enhancement, emergency response, seismic resiliency, and export water supply reliability. Future Project work incorporated into new or updated Five-Year Plans will follow criteria under the current Program Guidelines: 2014 Guidelines for Providing Funding to Local Public Agencies. The Guidelines are available at:

The Program will provide 100 percent cost share funding up to \$35,000 per plan to update existing Five-Year Plans and up to \$50,000 per plan for the development of new Five-Year Plans (the higher limit is only available to islands/tracts that did not participate in Five-Year Plan development in 2009). The Program will provide 50 percent cost share funding on new Five-Year Plans that exceed \$50,000, and on updates to an existing Five-Year Plan that exceeds the \$35,000 limit. The Program will not cost share plan development costs in excess of \$75,000 (0 percent State cost share).

Interested applicants are requested to submit a Five-Year Plan Letter Proposal requesting participation. Applicants who participate in the development of a Five-Year Plan must follow the requirements provided in the attached 2018 Requirements for Five-Year Plans. **Applicants are also encouraged to coordinate with local, State and federal agencies, as appropriate, while preparing their Five-Year Plans.**

This *Requirements for the Five-Year Plan* (Requirements) specifies the format and content for the Five-Year Plan (Plan) submittal in response to the 2018 Five-Year Plan Solicitation by the Delta Levees Special Flood Control Projects Program (Special Projects). Please also complete the *Table of Required Tabulated Information* in these Requirements. Items in the Table may be discussed separately in the Plan text but must be provided in tabular form for the Plan to be considered for funding.

### General Content:

- 1) A cover page.
- 2) A table of contents.
- 3) A clear description of each item listed in the Requirements.
- 4) An index for the appendices.

### Section 1: Executive Summary (recommend 1 page)

- 1) Provide a summary of the Plan, including:
  - a. The objective of the Plan.
  - b. The desired level of protection for the Local Agency's levee system.
  - c. How involvement with DWR will help the Local Agency achieve this goal.
  - d. How involvement with other agencies will help the Local Agency achieve this goal.

### Section 2: Background (recommend 5 pages)

- 1) **Assessment of the status of existing levee system**
  - a. Describe historical flood problems, including:
    - i) Dates of events.
    - ii) Estimated flood frequencies of events.
    - iii) Levee performance during these events
    - iv) Consequences of events.
  - b. What is the existing level of protection provided by the levee system? Include the source of this information. Specifically:
    - i) What portion of the levee is below or at the Hazard Mitigation Plan (HMP) Standard?
    - ii) What portion of the levee is at the PL84-99 or Bulletin 192-82 Standard?

    - iv) If the Local Agency is not able to reach the HMP Standard, explain why and what standard the Local Agency is working toward. Also, include the dimensions of the levee standard.
    - v) Provide cross-sectional surveys taken within the past five years for every 100 ft. of the Local Agency's levee system. If there are no existing surveys, contact the Delta Levees Special Projects Program; new field surveys will be funded under the Subventions Program.
  - c. Provide a map showing the existing level of protection by the levee system, including:

    - ii) The portion of the levee at the HMP Standard.
    - iii) The portion of the levee at the PL84-99 or Bulletin 192-82 Standard.
    - iv) The portion of the levee at above the PL84-99 or Bulletin 192-82 Standard.

**2) Previous Five-Year-Plan progress report**

- a. State if the Local Agency has previously submitted a Plan to the Program.
- b. Provide a review of your 2009 Five-Year Plan submittal, including:
  - i) Steps taken to achieve the objectives outlined in the Plan
  - ii) A statement of whether the objectives were achieved completely, partially, or not.
  - iii) If objectives were not achieved, provide a summary of why and what should be done differently to achieve the goals outlined in this Plan.

**3) History with the Delta Levees Program**

- a. Describe your past involvement with the Delta Levees Special Projects and Delta Levees Maintenance Subventions Programs. Include a statement as to whether and how that participation allowed the Local Agency to meet the 2009 Five-Year Plan objectives. Please provide as much information as possible.

- b. Phasing of the work, along with a list and description of proposed projects needed to achieve the five-year goal, including:
  - i) The stationing of levee improvements for each project.
  - ii) An approximation of the materials to be used for each project.
  - iii) Studies and reports that are anticipated to be conducted for each project.
  - iv) Provide a phasing map to specify the location of proposed projects.
- c. Total estimated cost of the work and its distribution for each project over the five years, including:
  - i) The estimated cost of planning, design and engineering, and construction costs.
  - ii) A paragraph describing any major assumptions made in the development of the cost estimate.
- d. Potential cost sharing with other partners (other than the Delta Levees Special Projects and Delta Levees Maintenance Subventions Programs).
- e. Requested cost sharing with the Delta Levees Special Projects Program, including:
  - i) A justification explaining how the Local Agency determined this amount
- f. Estimated schedule of work.
- g. A statement of how you expect the Delta Levees Special Projects and Delta Levees Maintenance Subventions Programs will contribute toward achievement of the five-year goals.
- h. A statement of how you expect other agencies to contribute toward achievement of the five-year goals.
- i. Discussion of potential constraints and obstacles to meet the desired level of protection and how the Local Agency plans to mitigate and/or overcome them

**2) Identification of need for improvements to reduce existing hazards**

The Plan should provide an inventory of the local and non-local assets and critical infrastructure, both public and private, that is protected by the levees. Local assets are those for which the Local Agency can levy assessments for flood protection; non-local assets are those that the Local Agency cannot levy assessments. The Local Agency should identify public benefits where applicable, such as:

The Plan needs to discuss levee risks. In particular:

- a. Consequences of levee failure or breach.
- b. Existing deficiencies in the system, including low spots, rapid settlement areas, erosion sites, undercutting, seepage, boils, or voids under the levee, including:
  - i) The location (stationing) of existing deficiencies.
- c. Urgency of repair work.

**4) Identification of opportunities for multi-benefit projects**

The Plan should, at a minimum, describe opportunities and significant constraints for achieving the following objectives:

- a. Ecosystem restoration and habitat enhancement.
- b. Reversing land subsidence.
- c. Ensuring adequate and effective emergency response plans.
- d. Improving water quality.
- e. Improving water supply reliability.
- f. Improving levee stability and integrity.
- g. Addressing Actions listed in the Governor's California Water Action Plan.

**Section 4: Plan for Permits and Habitat (recommend 2 pages)**

1. The San Joaquin County Mosquito and Vector Control District (the District) intends to apply public health pesticides to, over and adjacent to canals, ditches, or other constructed conveyance facilities owned and controlled by an entity other than the District, as well as surface waters and waters of the U.S. for vector control purposes per the requirements of the General NPDES Permit for Biological and Residual Pesticide Discharges for Vector Control Applications (the Permit) issued by the State Water Resources Control Board (SWRCB).
2. The NPDES Permit requirements for listing of the Public Health Pesticides anticipated to be used were modified from the previous permit being issued in 2016. The newer requirements specify that any pesticide product can be used that contains approved active ingredients, provided all pesticide label restrictions and instructions are followed. In addition, pesticides which fall under the "minimal risk" category can be used. The minimum risk pesticides have been exempted from FIFRA requirements. The following tables list the active ingredients approved for the FIFRA regulated pesticides.

4. The purpose of the use of larvicide and adulticide pesticides containing these active ingredients is to control immature and adult mosquitoes. Controlling mosquitoes will reduce annoyance and disease transmission to humans, domestic animals, and wildlife.
5. The general time period for the application of the pesticides is January through December, 2018. The locations of expected use will be canals, ditches, or other constructed conveyance facilities owned and controlled by an entity other than the District, as well as surface waters and waters of the U.S. within San Joaquin County, CA where immature and adult mosquitoes are found at treatment threshold levels.
6. There are no known water use restrictions or precautions during treatment.

Subject: Delta Levees Maintenance Subventions Program Applications for FY 2018-19

The Delta Levees Maintenance Subventions Program (Subventions Program) has been dedicated to maintaining and helping to manage the aging levees in the Sacramento – San Joaquin Delta for over 40 years. Since the passage of SB 541 (Way Bill) in 1973, more than \$195,000,000 has been reimbursed to local agencies for eligible levee maintenance and rehabilitation work in the Delta through the Subventions Program. The Disaster Preparedness and Flood Prevention Bond Act of 2006 (Proposition 1E), the Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006 (Proposition 84) and the Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Proposition 1), have all authorized DWR to provide local assistance under the Subventions Program to reduce the risk of levee failure and flooding in the Delta, as well as to ensure no net loss of habitat.

The Department of Water Resources (DWR) is now accepting applications for the Fiscal Year 2018-19 Subventions Program from eligible local agencies within the legal Delta. DWR is planning to make \$12,000,000 available from Proposition 1 funds for the FY 2018-19 Subventions Program. Upon receiving the annual levee maintenance applications from the local agencies, DWR will review the applications and prepare the FY 2018-19 Subventions Program annual funding plan. DWR will then seek approval of the FY 2018-19 funding plan from the Central Valley Flood Protection Board (Board). Please submit your levee maintenance application by April 1, 2018 in order to be considered for the FY 2018-19 Subventions Program. Applications may be submitted electronically to meet the deadline; however, a hard copy of the application with original signature(s) must follow by mail.

Please note that all applications must be in compliance with the 2016 Subventions Program Guidelines approved by the Central Valley Flood Protection Board on August 26, 2016. The Guidelines are available at the following DWR website:  
<http://www.water.ca.gov/floodsafe/fessro/deltalevees/subventions/>

The following are among the criteria that need to be satisfied prior to final approval of an application and/or disbursement of State funds (see the current Guidelines for comprehensive information):

- All engineering plans submitted to DWR must be approved by the local agency and must be prepared and signed by a Civil Engineer licensed by the California Board for Professional Engineers, Land Surveyors, and Geologists.
- Each FY 2018-19 application is required to include a method of assessment, assessed value, local agency tax rate for flood control, bonded indebtedness for flood control, and a summary of unpaid warrants for flood control work and/or their most recent audited financial report that includes the aforementioned items, as stated in the 2016 Subventions Program Guidelines, Article 3.1(g). The applicant will not be considered in good standing with the Subventions Program if the aforementioned information is not provided. This will result in a delay of FY 2018-19 final claim reimbursement until the required information is provided.
- The applicant must provide information regarding conformance with The Department of Industrial Relations Labor Compliance Program requirements of Propositions 1E (see Attachment A).
- Plans shall not result in a net long-term loss of riparian, fisheries, or wildlife habitat.
- The application must state that all habitat and mitigation requirements shall be completed to the satisfaction of California Department of Fish and Wildlife (CDFW). Failure to complete habitat and mitigation requirements as required will result in forfeiture of reimbursement under this program and may prevent future participation in the program.
- The applicant must ensure that the proposed work follows California Environmental Quality Act (CEQA) guidelines. The local agency shall be the lead agency for purposes of CEQA. However, both the Board and DWR, as responsible agencies, will review and consider the project's CEQA environmental document(s) prior to providing funding for any project that is subject to CEQA. Such approval is fully discretionary and shall constitute a condition precedent to any work for which it is required.
- In accordance with Water Code Section 9140, if the local agency is responsible for the operation and maintenance of a project levee, or if the local agency operates and maintains a nonprojected levee that also benefits land within the boundaries of the area benefited by the project levee, the local agency shall prepare and submit to DWR, on or before September 30th of each year, a report of information for inclusion in periodic flood management reports prepared by DWR relating to the project levee.
- In accordance with Water Code Section 9650, if the local agency receives funding from the State to upgrade a project levee that protects an area in which more than 1,000 people reside, the local agency responsible for the project levee and any city or county, including charter cities or counties, protected by the project levee shall enter into an agreement to adopt a safety plan within two years. The safety plan shall be integrated into any other local agency emergency plan and shall be coordinated with the state emergency plan. The local entity responsible for the operation and maintenance of the project levee shall submit a copy of the safety plan to DWR and the Board. No advances or reimbursements shall be made by the State for a levee covered by this paragraph until it receives the agreement from all necessary entities.

After final Board approval of the expenditure plan, DWR will prepare work agreements for execution by the Board and each participating agency. Timely execution of these funding agreements will help ensure that funding is committed. As always, participating agencies must be in compliance with all federal, State, and local laws and regulations in order for the Board and DWR to enter into agreement with the agency and consider reimbursement of the final claim.

Please be aware that unless extended by statute that the current Subventions Program not more than 75% state cost share in excess of one thousand dollars (\$1000) per mile of levee deductible will sunset and revert to a fixed 50% state cost share in excess of a one thousand dollar (\$1000) per mile of levee deductible on July 1, 2018 according to Water Code Section 12986. Please refer to the California Water Code for other provisions that will also sunset on this date.

## Attachment A

### DWR Labor Compliance for Grant Programs

- I. For every public works project — Prevailing Wage Compliance and Enforcement by Department of Industrial Relations
  - A. In addition to complying with other applicable laws, each bidder submitting a bid for such contract work must be a Department of Industrial Relations Registered Contractor pursuant to Labor Code Section 1725.5 (“DIR registered contractor”). A Bidder that is not a DIR registered contractor when submitting a bid for the contract work is deemed “not qualified.” Pursuant to Labor Code Section 1725.5, all subcontractors identified in a Bidder’s Subcontractor List shall also be DIR registered contractors.
  - B. All contractors who are awarded a contract, and all subcontractors of any tier, at all times during the performance of the work, shall be DIR registered contractors. Also, all such contractors and subcontractors must furnish electronic certified payroll records directly to the Labor Commissioner (of the Division of Labor Standards Enforcement).
  - C. The contracts are subject to compliance monitoring and enforcement by the Department of Industrial Relations.
- II. Additional requirements for projects utilizing Proposition 84 funds — Prevailing Wage Compliance and Enforcement through a Labor Compliance Program (LCP) — for a Prop. 84-funded job, in addition to the above requirements, the grantee will be required to comply with the following laws and regulations relating to LCPs:
  - A. The grantee must utilize a Labor Compliance Program (LCP) pursuant to Labor Code Section 1771.5, and the regulations promulgated thereunder (California Code of Regulations, Title 8, Sections 16421 et seq.), to be implemented through an LCP provider. Information about LCPs generally is available at [www.dir.ca.gov/lcp.asp](http://www.dir.ca.gov/lcp.asp).
  - B. The LCP provider will conduct a mandatory pre-job conference with the Contractor and its subcontractors to discuss federal and state labor law requirements applicable to the project. Contractor and its subcontractors shall be required to maintain and furnish to the LCP provider, at designated times, a certified copy of each weekly payroll containing a statement of compliance signed under penalty of perjury. The LCP provider will review and audit payroll records to verify compliance with applicable labor law. The LCP provider will also visit the jobsite and will randomly interview individuals to verify compliance with prevailing wage laws. The grantee may be required to withhold contract payments equal to the amount of underpayment and penalties, when, after investigation, it has been established that an underpayment or delinquency has occurred. Copies of the required rates are on file with the Department of Industrial Relations and available upon request. There are other requirements in the statutes and regulations.

The purpose of this letter is to clarify RD 1608's 9/13/17 approved encroachment permit. Per your request you have asked for clarification in an email to me on 2/5/18. Within that email you asked for confirmation that the District's 9/13/17 approval (copy attached - application dated 7/6/17) included the following:

1. You are approved to place lawn on the levee waterside slope of your lot.
2. You are approved to place artificial turf on the levee landside slope of your lot as noted and initialed by me.

Provided we receive a revised set of plans with a new encroachment permit application:

1. You will be allowed to leave the fire ring on the levee waterside slope.
2. You will be allowed to transfer the fire ring and concrete pavers to the levee landside slope.
3. You may be allowed to construct a deck in the area of the Fire Pit on the levee waterside slope provided it is in accordance with the District's Encroachment Standards.
4. Your 2/7/18 submitted Application and Plans, (copy attached - application dated 12/19/17), were not approved need revision and resubmittal.


With respect to the concrete surfacing of the levee crown, I have agreed to delay enforcement on this encroachment until such time RD 1608 has completed its revisions to its Encroachment Standards. As we discussed, RD 1608 is in the process of updating their Encroachments Standards and one of the elements that they are considering is the type of allowable surfacing of the levee crown in the Southwest Quadrant. Currently RD 1608 is considering allowance of concrete slab surfacing, provided the concrete slab surfacing is properly designed to handle the load of large earthmoving loaded trucks



that use the crown roadway for levee access. The burden of design proof would likely fall on the individual landowner yet the Encroachment Standards have not been completed nor edited at the time of writing this letter to you.

I anticipate this clarifies matters that we discussed on my 1/25/18 field inspection with you and Joe Bryson. If you have any questions please contact me. I look forward to receiving revised plans depicting the intent of the relocated pavers and potential fire pit along with the possibility of a deck for the fire pit on the levee landside levee slope.
